

MEMORANDUM OF UNDERSTANDING BETWEEN LYCEUM OF THE PHILIPPINES UNIVERSITY- BATANGAS, INC. AND MUHAMMADIYAH UNIVERSITY OF SEMARANG, INDONESIA



1. Preamble

Lyceum of the Philippines University- Batangas, Inc., the Philippines and Muhammadiyah University of Semarang, Indonesia agree to become parties to this Memorandum, the purpose of which is to encourage collaboration between both institutions. This also desires to enhance international cooperation for the advancement of research and teaching as well as to promote cultural understanding of their respective countries.

2. Scope

- 2.1 The scope of cooperation includes, but not limited to the following areas:
 - 2.1.1 Collaboration in recruiting and/ or training students following degree and non-degree programs;
 - 2.1.2 Exchange of students;
 - 2.1.3 Visits by possible interchange of faculty for the purpose of research, teaching and development;
 - 2.1.4 Research collaboration in the areas of mutual interest to both parties;
 - 2.1.5 Information exchange, including library materials, internet publications and research publications, where each party respects copyright and intellectual property rights;
 - 2.1.6 Other agreed joint development activities;
 - 2.1.7 May conclude specific agreements that are mutually agreed upon for the purposes of implementing programs and/ or activities pursuant to the provisions of this Memorandum. Such specific agreements shall define the relevant programs and/ or activities concerned.
 - 2.1.8 Both parties accept that any further activity under this Memorandum is subject to the availability of financial resources, and that supply of resources should be negotiated prior to activity;
 - 2.1.9 Each party may request in writing a modification or amendment of any part of this Memorandum. Any modification or amendment agreed by both parties shall be written down. Such modification or amendments once approved by both parties will become part of the Memorandum.
 - 2.1.10 Any difference or dispute arising from this Memorandum should be resolved through mutual consultation and negotiations between the parties.

3. Duration

- 3.1 This Memorandum will be effective for a period of 2 years from the date of signature, during which time it shall be reviewed to establish mutual consent as to whether collaboration between the parties should continue after that time.
- 3.2 The scope of this Memorandum may be extended by mutual agreements.
- 3.3 Both the institutions reserve the right to independently terminate the MOU at any time giving three (3) months written notice in advance.
