



## Memorandum of Understanding

Between

GWANGJU HEALTH UNIVERSITY, OFFICE OF GLOBAL AFFAIRS, KR (INSTITUTION A)

and

UNIVERSITY OF MUHAMMADIYAH SEMARANG, ID (INSTITUTION B)

Each INSTITUTION, wishing to establish a cooperative relationship through mutual assistance in the areas of job training, language education, and foreign national student exchange, agree as follows:

### Article 1: Scope of Collaboration

- 1.1 *General Scope.* Each INSTITUTION may offer to the other opportunities for activities and programs such as academic collaboration, internships, language camps, faculty and student exchanges, and employment support.
- 1.2 *Specific Programs.* Specific Programs implemented under the authority of this MOU shall be subject to funds and the approval of each INSTITUTION's authorized representatives.

### Article 2: Renewal, Termination and Amendment

- 2.1 *Duration.* This MOU will become effective upon the date of the last signature. Either INSTITUTION may terminate this MOU by providing 60 days advanced written notice to the other INSTITUTION.
- 2.2 *Amendment.* No amendment of the terms of this MOU will be effective unless made in writing and signed by each INSTITUTION's authorized signatory.

### Article 3: Indemnification

- 3.1 *Resolution.* In the case of conflicts regarding this MOU and any relevant appendices, an amicable solution shall be provided upon agreement by authorized officials.

### Article 4: General Matters

- 4.1 *Notices.* The INSTITUTIONS must give all notices under this MOU in writing to the addresses set forth below or to such other address designated by the parties by written notice.


