6. The co-operation agreement can be supplemented by annexes in order to implement certain joint activities.

IV. VALIDITY AND TERMINATION OF THE AGREEMENT

- 7. This agreement shall be in force from the day it is signed and will be valid for five years. It shall be automatically renewed for five more years unless intimation given otherwise by either Party.
- 8. The agreement may be terminated by either Party upon a three-month written notice to the other Party.


